A Resolution to Participate in the 2016 Performance Measures Program

WHEREAS, the 2010 Legislature created the Minnesota Council on Local Results and Innovation, and

WHEREAS, in February 2011 the council released a standard set of ten performance measures for counties that will aid residents, taxpayers and state and local elected officials in determining the efficacy of counties in providing services, and

WHEREAS, counties that elect to participate in the Performance Measures Program for 2016 are eligible for a reimbursement of \$0.14 per capita in local government aid, and are also exempt from levy limits under section 275.70 to 275.74 for taxes payable in the following calendar year, if levy limits are in effect, and

WHEREAS, Murray County was certified for the program in 2011, 2012, 2013, 2014 and 2015. NOW THEREFORE BE IT RESOLVED, by the Murray County Board of Commissioners that Murray County hereby elects to participate in the 2015 Performance Measures Program.

BE IT FURTHER RESOLVED, that the following performance benchmarks are adopted by the Murray County Board of Commissioners:

- **Public Safety**: Part I and II Crime Rates, as Reported by the Minnesota Bureau of Criminal Apprehension; Deputy Response Time; total number of accidents that occur on County State Aid Highways, County Roads and Un-Organized Township Roads that involve fatalities and injury.
- **Probation/Corrections**: Percent of adult offenders with a newly felony conviction within three (3) years of discharge.
- **Public Works**: Hours to plow complete system during a snow event and Average County Pavement Condition Rating, Based on County Engineer's Evaluation.
- **Public Health**: Life Expectancy Generally and by Sex and Race.
- Social Services: Workforce Participation Rate Among MFIP and DWP Recipients and Percentage of Children Where There is a Recurrence of Maltreatment Within 12 Months Following an Intervention.
- **Taxation:** Level of Assessment Ratio.
- **Elections:** Accuracy of Post-Election Audit.
- Veterans' Service: Percentage of Veterans Surveyed Who Said His/Her Questions Were Answered When Seeking Benefit Information from the County Veterans' Office.
- **Parks**: Citizens' Rating of the Quality of County Parks, Recreational Programs, and/or Facilities.
- **Libraries**: Number of Annual Visits per 1,000 Residents.

BE IT FURTHER RESOLVED, that the results of the adopted performance measures will be published on the Murray County Website by December 31, 2016.

Resolution Adopting Assessment against Real Property Connected to Shetek Area Water and Sewer District ("SAWS")

WHEREAS, pursuant to proper notice duly given as required by law, the Murray County Board has met and heard and passed upon all objections to the proposed assessment for the Shetek Area Water and Sewer District ("SAWS") sewer system;

NOW THEREFORE, BE IT RESOLVED BY THE COUNTY BOARD OF MURRAY COUNTY, MINNESOTA:

- 1. Such proposed assessment, a copy of which is attached hereto and made a part hereof, is hereby accepted and shall constitute the special assessment against the lands named therein, and each tract of land therein included is hereby found to be benefited by the proposed improvement in the amount of the assessment levied against it.
- 2. Such assessment shall be payable in equal annual installments extending over a period of <u>13</u> years, the first of the installments to be payable with the first half of the real estate taxes due and payable in <u>2017</u>, and shall bear interest at the rate of <u>3.100</u> percent per annum from the date of the adoption of this assessment resolution. To the first installment shall be added interest on the entire assessment from the date of this resolution until <u>December 31, 2016</u>. To each subsequent installment, when due, shall be added interest for one year on all unpaid installments.

The foregoing resolution was duly seconded by Commissioner Thiner and thereupon being put to a vote all members of the Board voted for its adoption.

RESOLUTION 2016-04-19-04 RESOLUTION RELATING TO BUFFALO RIDGE DRUG TASK FORCE PER CAPITA FUNDING

WHEREAS, the Counties of Murray, Nobles, and Pipestone, by and through their Sheriff's Departments, and the Cities of Adrian, Fulda, Slayton, and Worthington, by and through their police departments (sometimes referred to herein as the 'parties'), have formed and operate a task force for the purpose of coordinating regional drug enforcement efforts; and

WHEREAS, the parties have determined that the task force should be called the 'Buffalo Ridge Drug Task Force; and

WHEREAS, the parties have determined that, pursuant to Minn. Stat. §471.59, they should form a Joint Powers Agreement for the purposes of coordinating and administrating Buffalo Ridge Drug Task Force efforts, and to receive law enforcement funds available for regional narcotics task forces through the State and Federal Government;

WHEREAS, the Counties of Murray, Nobles and Pipestone, have annually supplemented state and federal funds with a \$3.00 per capita fund and have determined the need to incrementally increase the per capita to support the task force effort;

NOW THEREFORE BE IT RESOLVED, Murray County shall increase its respective per capita fund (if approved by the other member entities) to not less than \$3.50 in 2017, \$3.70 in 2018, \$3.90 in 2019, \$4.10 in 2020, \$4.30 in 2021, \$4.50 in 2022, and the per capita fund shall be reviewed annually thereafter.

The foregoing resolution was duly seconded by Commissioner Jens and thereupon being put to a vote all members of the Board voted for its adoption.

WHEREAS, after further review of the benefits that could result from partnering with Western Community Action, the County of Murray wishes to consolidate the Murray County Transit system with transit services of Western Community Action at the same high quality of service that currently exists;

WHEREAS, the County of Murray will provide to Western Community Action financial support and involvement in the operation of public transportation within the Murray County service area;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY OF MURRAY, MINNESOTA, that Western Community Action will move forward with entering into a service agreement that will begin August 1, 2016.
