December 12, 2017, 8:30 a.m.

Pursuant to notice, the Murray County Board of Commissioners convened with the following members present: Commissioners Glenn Kluis, Gerald Magnus, Lori Gunnink, James Jens and David Thiner. Also, present Aurora Heard, County Coordinator and County Attorney Travis Smith.

The meeting opened by reciting the Pledge of Allegiance to the Flag.

The Chairman asked if there were any additions to the agenda. Several items were added.

It was moved by, seconded by and passed to approve the agenda as modified.

No conflicts of interest were identified.

Tessia Melvin, David Drown Associates, recommended the following regarding the previous appeals:

- Deny Chief Deputy Auditor/Treasurer appeal as it is based on longevity and you would have to do it for everyone;
- Deny Deputy Recorder appeal;
- Community Relations & Economic Development –They were not appeals;
- Deny Highway Maintenance Worker appeal;
- Highway Maintenance Workers/Signs – Recommended increasing one labor grade;
- Sheriff’s Department – She reviewed the following three options: 1. Keep the Lieutenant position as per Job Description Appeal Process, 2. Eliminate the Lieutenant position create Drug/General Investigator position, 3. Do nothing with these positions until Sheriff approaches the Board and determines this position and other additional positions.

Tessia Melvin recommended approving the highway maintenance/sign position as additional responsibilities were brought in and denying the other appeals. Regarding the Sheriff’s Department she recommended further conversation and discussion with the Sheriff regarding the positions in his office. She stated this was a compensation/classification study not a reorganization.

It was moved by Thiner, seconded by Magnus and passed to approve Tessia Melvin’s recommendations: the highway sign maintenance position increases a labor grade and the following three stay the same: Chief Deputy Auditor/Treasurer, Highway Maintenance Worker, Deputy Recorder and the Sheriff’s Office will have to be figured out.

Christy Riley met with the County Board regarding surplus items.
