

PROCEEDINGS OF THE MURRAY COUNTY BOARD OF COMMISSIONERS
MURRAY COUNTY GOVERNMENT CENTER – SLAYTON, MINNESOTA
December 14, 2017, 10:30 a.m.

Pursuant to notice, the Murray County Board of Commissioners convened with the following members present: Commissioners Glenn Kluis, Lori Gunnink, James Jens and David Thiner. Also, present Aurora Heard, County Coordinator, Laurel Pugh, County Labor Attorney. Excused Absence: Commissioner Gerald Magnus.

10:30 a.m. The County Board met with Law Enforcement Labor Services.

LELS Local #131 makes the following proposals for amendments to the collective bargaining agreement between Local #131 and Murry County.

1. ***Duration (Article 30):*** *The Union is proposing a one year labor agreement January 1, 2018 – December 31, 2018*

2. ***Wages (Article 20):***

To be discussed at the bargaining table.

3. ***Work Schedules and Work Hours (Article 10):***

10.8. The Union is proposing to increase the callback time from a minimum of two (2) hours, to three (3) hours.

4. ***Court Time (Article 12):***

12.1. The Union is proposing to increase the court time minimum from two (2) hours to three (3) hours.

5. ***Holiday (Article 17):***

The Union is proposing the following language changes as follows:

709B

- II, sub (1), ~~8 hours pay~~, compensation for all hours worked.*
- II, sub (5), ~~8 hours pay~~, compensation for all hours worked.*

6. ***Uniform Allowance (Article 26):***

The Union is seeking an increase in the Uniform Allowance as follows:
1/1/2018 an increase from ~~\$800.00~~ to \$900.00

7. ~~Appendix A~~

On January 1, the employer will award Employees who do not receive a step increase because they are at step 10 on the salary schedule in 2018 a cash payment of \$850.00, and in 2019 a cash payment of \$950.00.

12:50 p.m. The meeting was recessed.

2:00 p.m. The meeting was called back to order.

A three year contract was agreed to beginning January 1, 2018-December 31, 2020, with a 2.5% COLA and a step increase in 2019; a 2.5% COLA and a step increase in 2020.

Items 3, 4, 5, and 6 were agreed too. Item 7 was dropped. The following hourly wages were agreed to for 2018:
