WHEREAS, a public hearing was held on Tuesday, January 2, 2017 at 10:15 a.m. in the Commissioners Room of the Murray County Courthouse; and

WHEREAS, public notice was given pursuant to Minn. Stat. § 103E.806, subd. 3; and WHEREAS, the hearing was open to public comment and there were questions raised by the Township and others attending the meeting.

NOW, THEREFORE, based on the testimony and written documentation, the Murray County Board of Commissioners, acting as Drainage Authority for Murray County Ditch #68, makes the following Findings of Fact and Order:

FINDINGS OF FACT

- 1. That Petitioners are the owners of property situated in the NE ¼ of Section 21 of Slayton Township, Murray County, Minnesota, that is benefited by Murray County Ditch #68.
- 2. That the portion petitioned to be abandoned on Murray County Ditch #68 does not serve a substantial useful purpose to any property remaining in the system and are not of substantial public benefit and utility
- 3. That the abandonment, under Minnesota Statutes 103E.806, does not in any way change the benefits for Petitioners' properties.

ORDER

NOW, THEREFORE, it is hereby ordered that the entire length of Branch B, County Ditch 68 from Station 47 (0+00) to Station 20+50 (2050 feet) and located on Petitioners' properties shall be abandoned subject to the completion of the above conditions. This order does

not release Petitioners' properties from any benefits under the current Benefits and Damages Viewers' Report. It is further ordered that those portions of Murray County Ditch #68 that are not abandoned shall be determined to be part of the Murray County Ditch #68 system.
